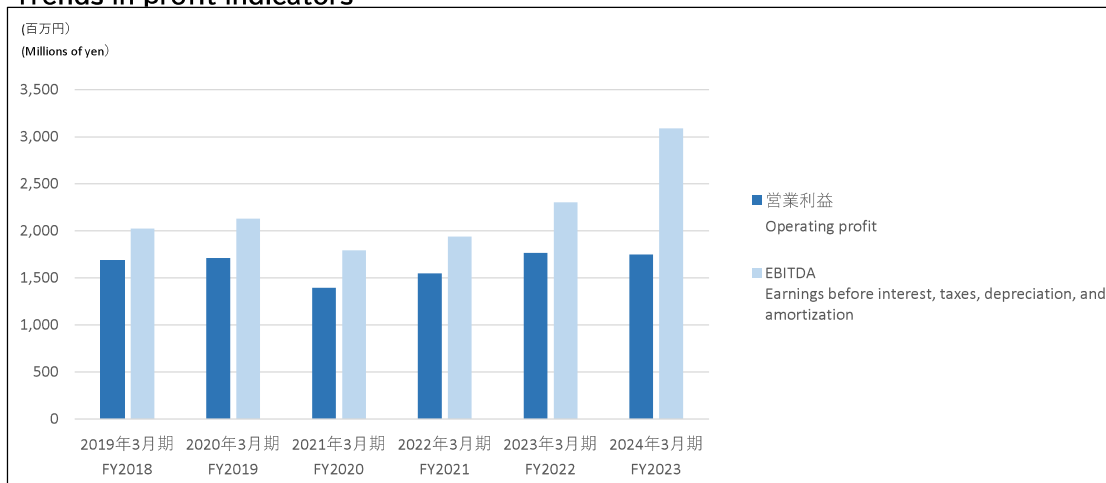

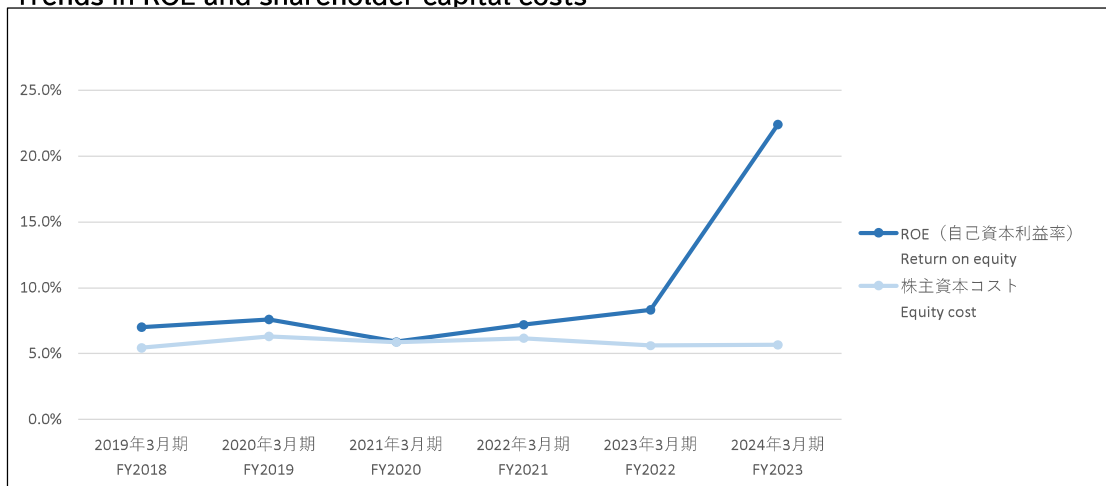

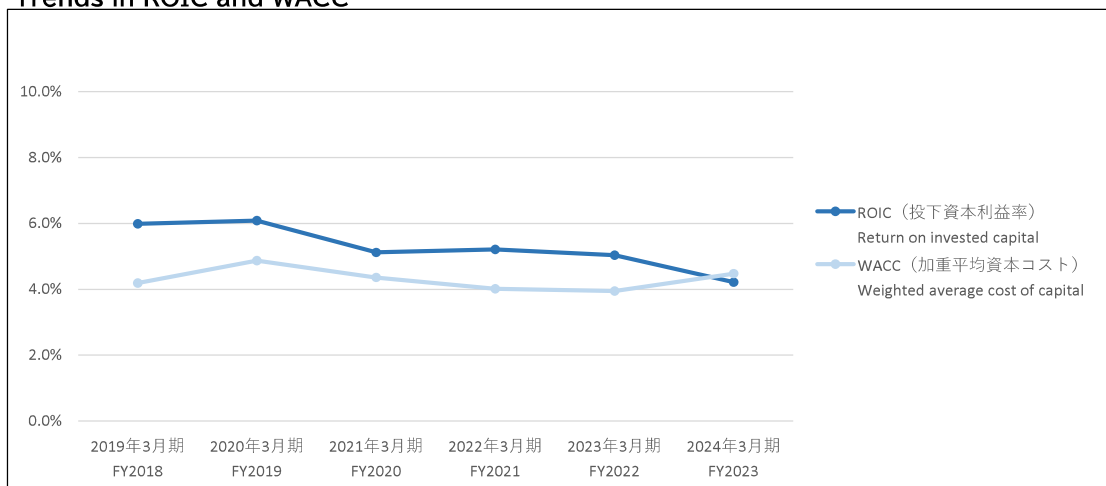
利益指標の推移 Trends in profit indicators
